



Memorandum of Understanding

This memorandum of Understanding (MOU) is executed this MOU [Here in after called the MOU]

Between

SESHASAYEE PAPER AND BOARDS LIMITED, Unit :- Tirunelveli, a company incorporated under the comp[any Act, 195 having its registered office at Erode and Industry at Elanthaikulam, Singamparai Post, Mukkudal (via, Tirunelveli - 627 601, Tamilnadu (here in after referred as "SPB-TVL" which expression shall, unless it be repugnant to the context or meaning there of, be deemed to mean and include its group companies, affiliates, successors and permitted assigns) of the one part.

And

PSN ENGINEERING COLLEGE, Tirunelveli: - an Institution (here in after referred as "PSNEC" which expression, unless it be repugnant to the context or meaning there of, be deemed to mean and include its successors in business and permitted assigns) of the other part.

"SPB-TVL" and "PSNEC" shall be referred as "Party" and jointly "Parties" as the case may be in below. SCOPE:

- "SPB-TVL" undertakes tp imp[art the Internship training program to the students of the institution and to offer in the thrust area of engineering domain. The students and faculty members shall undertake projects in "SPB-TVL". These projects will be jointly monitored by the "SPB-TVL" executives and Institute Guide, who shall also responsible for the students. On completion of the projects "SPB-TVL" will issue the certificates. Funding of project by "SPB-TVL" is out of scope of this MOU.
- "SPB-TVL" shall designate the interns as "Trainees" in their organization. During the period of training and the project work and also after its completion, students shall have regular interaction with the "SPB-TVL" mentors and the Guides.
- To provide industry exposure to the students of "PSNEC" through group visits.
- To share the knowledge resource of managers / executives of "SPB-TVL" by arranging guest lectures at "PSNEC".

Responsibilities of Party 1: (SPB-TVL)

- 1. To provide internship for the students of Mechanical Engineering, Automobile Engineering, Mechanical Automation Engineering, Civil Engineering, Electrical and Electronics Engineering and Electronics and Communication Engineering.
- 2. To offer infrastructure facility for the selected projects to the extent possible.
- 3. To provide In-Plant Visit of the students.
- 4. To extend the knowledge with join collaboration.

Responsibilities of Party 2: (PSNEC)

- 1. Based on the selection process, the (PSNEC) will select 6 to 10 candidates per year for the internship program.
- 2. The Institute (PSNEC) will have to give permission for the selected students for internship training and to do their projects in SPB-TVL
- 3. In order to monitor the students, the institute's (PSNEC) guides shall frequently interact with the SPBL mentor then and there.

General Terms and Conditions:

- 1. No scholarship will be extended to the interns by "SPB-TVL".
- Students shall, during the period of training and project work, abide by the rules and regulations of the company.



- 3. All interns shall strictly follow the regulations of the SPB-TVL and Institute (PSNEC) shall ensure that they are covered by suitable accident insurance.
- 4. SPB-TVL shall not be responsible for any accident or injury sustained by any interns during the period of training.
